Mike Walsh commented that he's not against the proposed Mindiola baseball park, but he wants the City to keep a few things in mind and make sure the money works. He expressed concern that the \$12 million would not become general fund usage until years down the road, so he felt other areas in the CIP budget should be cut back, such as City Hall and Buchner Pool renovations. He said that taxpayers of Waukesha are already strapped for taxes and suggested that a user fee, such as a small City charge on all tickets for the games and on concessions would be a good idea to raise revenue to offset costs of such a project.
