Towing Ordinance - Final

Asst. City Attorney Miles Eastman spoke regarding the draft ordinance; Capt. Wagner spoke on same.

Ald. Rodriguez is not in support of this draft; she said it comes down to someone not paying 5 parking tickets which could result in the towing of a vehicle.

Ald. Perry questioned if the offender pays the "cost" or "charge" for towing; Eastman said the state statute reads that they pay the cost and we would be relying on the towing contractor as to what the cost is. He said the ordinance doesn't require a breakdown by the towing company of cost vs. charge. Eastman said it would be fairly difficult for us to get from the towing company what their actual cost is. Perry is in favor of personal contact made and not mail. Wagner said the vehicle would be tagged with a large sticker on the window for notice.

Lemke is in support of the ordinance to promote law enforcement. He does not want to make it easy for those that are breaking the law.

Capt. Wagner said there is a contract now with Elder Towing, the cost varies with the type of vehicle and how much time it takes them to tow the vehicle. He did not have the charges readily available.

Ald. Manion is inclined to support the ordinance, however, he would like to know the costs that would be charged to the owner; would like to see a cap, limit or structure to those fees. Eastman said the statutes says that our ordinance should provide for a "reasonable" cost for removal of the vehicle.

Capt. Wager quoted from the Elder's Towing website: storage \$45/day, indoor storage \$55/day, towing \$150 on average.

Rodriguez stated that a notice 24 hours prior to towing doesn't mean you will see the notice.

Chairperson Johnson said he has no problem with this; he said towing is reasonable if someone has over 5 tickets that are over 60 days old.

A motion was made by Chairperson Johnson, seconded by Manion, to approve the ordinance amendment as proposed. The motion carried by the following vote:

Aye: 3 - Manion, Johnson and Lemke

Nay: 2 - Perry and Rodriguez
