**CONSENT AGENDA** 

Engineering staff presented several options to the Committee on creating a better merge condition for eastbound traffic. The options ranged from additional signing at low cost to full reconstruct at very high cost. Staff presented option 3 which was to install new

pavement marking on eastbound E. Sunset Drive to allow for two lanes of traffic to travel eastbound to Guthrie Road. The Committee unanimously agreed that option 3 should be implemented. The Committee voted unanimously to approve Option 3 and to approve using \$3,100 to fund the pavement markings. The \$3,100 will come out of the Building and Grounds Safety Projects account #3310.54141

A motion was made by E. Payne, seconded by D. Lemke, to install new pavement marking on eastbound E. Sunset Drive to allow for two lanes of traffic to travel eastbound to Guthrie Road and to fund the pavement marking installation at a cost of \$3,100 to be paid for out of the Building and Grounds Safety Projects account be approved. The motion carried unanimously.
