Lt. Hendricks spoke on this item. The Police Department feels this was probably overlooked when the CSO program started. They now have CSO's employed year round and they are out in the city, not just in the parks. They would like the CSO's to have the authority to write parking tickets. D. Lemke asked if the CSO's or the parking agents have more training; Hendricks said the CSO's go through 2 weeks of training and the PD feels they are capable to write parking citations. R. Lemke asked if a CSO written ticket would be a defense; Asst. City Attorney Eastman said as long as the ordinance allows for it, it would not. Johnson asked if CSO's duties would be changed due to this; Hendricks said their mission would not change, it would just allow them to not have to call an officer to a scene to write a ticket.
