Ald. Browne of District 1 appeared before the Committee. He spoke in favor of the animal ordinance being amended to allow up to 4 dogs. The current ordinance states that a household can have up to 2 dogs and 2 cats. He introduced Lynn Cleppe, a resident of his district that was also in favor of increasing the dog limit. Ms. Cleppe spoke to the committee in favor of the ordinance change.

Ald. Rodriguez spoke in favor of the change and recomended Ald. Browne work with City Attorney Brian Running on drafting an ordinance change. That draft would then be discussed and considered at the next O&L meeting.

Ald. R. Lemke & Ald. D. Lemke stated they are opposed to the ordinance change.

Ald. Manion stated that he would like to hear from Community Development on the proposed ordinance change. He asked Lt. Habanek if he could provide the amount of calls that the Police Department receives related to animal noise complaints. Lt. Habanek stated he would get that informaton for the committee.
