*Amari Watson appeared with agent, Mark Hannon, Hannon's Fine Food and Cocktails. Ald. Johnson asked Hannon if he is aware of the issues on Watson's record. Hannon stated he spoke with her, but does not know the specifics of her record. Ald. Johnson asked her about the pending charge of Possession of Controlled Substance, she stated it is still in the process of being adjudicated. Ald. Rodriguez stated she would like more information about the Misappropriate ID charge. Rodriguez stated it is a concern because she would be responsible for checking ID's. Watson stated she was 17 years old and was dating a boy that was not a good influence on her and has not been in any trouble of that nature since the charge. Rodriguez asked if the Misappropriate ID charge led to the multiple Probation Violation charges, she said yes. Rodriguez asked if there were incidents after that charge, Watson said yes. Johnson mentioned her Operating While Suspended and Possession of Controlled Substance and stated they are currently pending, she stated yes. Deputy Chief Angle from the City of Waukesha Police Department reviewed Watson's record and stated the Police Department does not recommend approval for Watson's Bartender Application. Angle stated there are too many rule infractions and based on her background does not seem like somebody that would be a responsible server.*

*Rodriguez asked Hannon based on the background discussed, if Hannon's position would change on being the Agent responsible and having his business liable for Watson's application. Hannon stated he would need more information. Rodriguez stated Hannon is ultimately responsible for Watson and her application. Hannon stated again, he would need more information.*

*Hannon asked if Watson could reapply if her bartender application is denied at this time, Johnson stated Watson currently has charges pending for the courts and suggested waiting for the pending charges to close prior to reapplying.*
