Ald. Rodriguez and Ald. McElderry have raised concerns regarding code 3.08. Alderman would like to review and take action as needed in revising or creation of policies.

Ald. McElderry has concerns about the appointment of citizen members and if there has been any action to fill the positions. Director Kelley stated the Mayor is in the process of filling vacancies.

Ald. Rodriguez reading the policy and inquired if Director's Report will include financial report. Previous Director was providing a handout but Pat Grulke is unsure if that was being passed to Common Council. Director Kelley would like to know what data was shared previously.

Pat Grulke would like to discuss as a Commission or as a separate committee 3.08 with Director Kelley to establish the Commission expectations and review Council expectations and facilitation.

Director Kelley inquired about past practicies for financial summaries.

Pat Grulke and Ald. Rodriguez are indifferent to formation of subcommittee but would like to be members.

#### 5. Reports

### a. Cemetery Manager's Report

Director Kelley updated administration building work continues and temporary workstations created until furniture delivery from police station.

Sales last month was \$42,819.15, year to date is \$122,897.26. Burials year to date is 51. Last month there were 14 total burials. Five full size, five in ground cremations, one natural and three niche.

Would like to provide future reports with the excel spreadsheet with details per 3.08. End of report.

Ald. Rodriguez asked Lee to email a copy of those numbers.

Pat Grulke asked when is the target opening date of the building? Director Kelley stated next week is the tentative timeline.

Ald. Rodriguez stated concerns that the cemetery main line is not being answered because no one is in the building. Director Kelley responded that we use the MiCollab app, that all city employees use, but it does not work every time.

Ald. Rodriguez also asked how Commissioners receive their agendas. Agendas are not sent out or posted to Granicus. She made referral to establish the citizen emails for Commission members and asked Lee to follow up with Kevin or IT and implement.

Ald. Cummings inquired about digitization and handling of records. Voiced concerns about disposal after completion. Confirm with Mary Emery before record destruction. Director Kelley stated that everything sent out will be returned to us for keeping. Ald. Cummings asked about the process, documents sent out for sanitizing, then secured and digitalized, and the paper document is returned to cemetery. Director Kelley stated this is correct.
