Ron Grall, Director of the Parks, Recreation & Forestry Department presented this item. He explained the current connection on Lincoln Ave. has heavy truck traffic and is industrial. The goal is to get the key connection from Frederick St. around Eaton and WE Energies' properties. The connection will get you off the street safely to the Carroll connector. The change order is for 4 ft. chain link fencing. The same application on both sides. The 700 lin. ft. wood fence that was bid won't cut it. The chain link will be more durable in the long term and be low maintenance and prevents graffiti.

8. Matter of Report

Alex Damien reported that on the construction projects : St. Paul Ave. the majority of the paving is done, things are going well. There was a cross-bore of a utility line on Wisconsin Ave. and another on Madison Street. Through the sewer televising practice that was implemented several years ago, we find things so many different things. In the past, on Arcadian a contractor bored through the new sanitary sewer in three different locations. Unfortunately this will set a back but it's good that they were found now so they can be fixed.

- A. <u>ID#22-4412</u> Review the practice for charging condemned sidewalk replacement costs to adjacent property owners.

Referral from Ald. Cory Payne to review the practice for charging condemned sidewalk replacement costs. Prefer to have him explain it, however, Alex Damien talked with him briefly about what he is looking for. Alex Damien stated that it has been a long-term policy and practice and encompasses ordinances and state statutes that would have to be looked at and reviewed to see what would have to be adjusted. If you support this, ask staff to review and report back the consequences and to make a recommendation for the financial impact and policy recommendation. Ald. Pieper asked if staff has an idea what is billed out. Alex Damien responded that it varies from year- to-year, it could range from \$20,000 to \$100,000 - not huge cost given the overall budget but it's mostly the policy and practice.

Ald. Pieper motioned for staff to look into the financial implications of the particulars of this referral and report back when the information is available. Focus on existing sidewalk that needs to be replaced. Kevin Reilly added to look at the existing sidewalk - and implications for different homeowners, looking at highest and lowest assessment included.
