Agenda Item Title:

Certified Survey Map - 735 Pleasant St., La Casa de Esperanza – A request to approve a 5.1402 acre one lot CSM to consolidate 13 parcels owned by La Casa de Esperanza south of Arcadian Avenue west of the rail road tracks, into 1 Lot.

Issue Before the Council: Review and act on a proposed CSM for approximately 5.1402 acres of land owned by La Casa de Esperanza south of Arcadian Avenue west of the railroad tracks, to consolidate 13 parcels owned by La Casa de Esperanza south of Arcadian Avenue west of the rail road tracks, into 1 Lot.

Options & Alternatives:

- Approve the proposed one lot CSM
- Deny the request and the property will remain in 13 separate parcels, making future redevelopment difficult.

Additional Details: La Casa De Esperanza has acquired multiple properties south of Arcadian Avenue west of the railroad tracks and is requesting the rezoning of 5.1402 acres of land owned by La Casa de Esperanza to I-1 Institutional District to be consistent with their campus north of Arcadian Ave. Combing the 13 parcels into one lot will consolidate the property boudaries making it clear of the ownership and avoid any lot line set back descrepencies.
