- 1. Public sanitary sewers shall be designed and installed per the City's requirements. Plans & profile sheets, Details, and Notes on the drawings shall meet the requirements in the Developer's Handbook.
- 2. The public sanitary sewer shall extend to the existing manhole on the southern end of Winterberry Dr to eliminate the existing pump station in conformance with the City's Sanitary Sewer Master Plan. The elimination of the pump station shall be included with the installation of the sanitary sewer.
- 3. The sanitary sewer shall be lowered to match the downstream invert. The sewers were designed at a 0.50% slope with 0.1 and 0.25 drops at the manholes. Any additional elevation remaining at Winterberry can be adjusted in the last section.
