Resolution No. 2026 – 16**

Resolution Directing the Placement of Parking Signage

Be it resolved by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes is directed to place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

Install “Playground, Speed Limit 15mph When Children Are Present” signs on northbound Rivers Crossing Drive north of Stillwater Circle. Install pedestrian crossing signs on Rivers Crossing Drive at Tanglewood Drive. Install transverse pedestrian crosswalk markings at the intersection of Rivers Crossing Drive at Tanglewood Drive and a stop bar for Tanglewood Drive at Rivers Crossing Drive. [#26-02827]

Establish no parking on the north side of Gascoigne Drive 60’ west of Pewaukee Road to 45’ east of Pewaukee Road. Establish no parking on the south side of Gascoigne Drive 40’ west of Pewaukee Road to 215’ east of Pewaukee Road. [#26-03972]

Install “Cross Traffic Does Not Stop” plaques for Spring City Drive at Chapman Drive. [#26-03966]

Rescind the previously approved resolution dated May 16, 1978, which established one-hour parking on both sides of W. Newhall Ave. from Walton Ave. to S. West Ave. between 7:00 A.M. and 5:00 P.M. except Saturday, Sunday, and Holidays. [#26-03967]

Install advance warning signs of "No Trucks 3 Tons and Over" signs for southbound River Valley Road south of USH 18. [#26-03968]

Install "Engine Brake Mufflers Required" sign for southbound STH 318 south of Silvernail Road. [#26-03970]

Extend the existing No Parking Zone on the west side of N. Hartwell Ave., from the south side of the driveway for #530 N. Hartwell Ave. to 30' South. [#26-03971]

Install "Caution Children with Disabilities Area" warning signs for northbound and southbound Meadow Lane. [#26-03979]

Install a stop sign for northbound Winterberry Drive at Tallgrass Circle. [#26-03980]

This resolution was approved at the July 6, 2026, Building and Grounds Committee meeting and brought forward to the July 21, 2026, Common Council meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

Be it further resolved that the City Clerk shall file this resolution in their office as part of the original City records.
