## **Agenda Item Title:**

Conditional Use Permit - 3725 Stillwater Court, James Guenther Cigars - A request to operate a wholesale cigar purchasing business, along with the occasional sale of cigars, at the house at 3725 Stillwater Circle as a Home Industry in the Rs-3 Single Family Residential District.

**Issue Before the Council:** Proposed small-scale cigar distribution business in a home.

**Options & Alternatives:** The Plan Commission could approve the application with or without conditions, or deny it. If the application is denied the proposal will not be able to go forward.

**Additional Details:** 3725 Stillwater Court is a duplex condominium. The applicant has stated that he is a cigar enthusiast and would like to purchase cigars wholesale, primarily for his personal use, rather than buying them from a retail store. He plans to sell small quantities of cigars to family and friends only. He will store cigars at his house, but he will personally deliver any sales.

In order to purchase cigars from a distributor, the applicant needs a Cigarette and Tobacco Products Retailer License, which will be reviewed by the Ordinance and License Committee. The license cannot be approved unless the business is permitted by the zoning code, or has a Conditional Use Permit where applicable.

Home based businesses can either be categorized as a Home Occupation, or a Home Industry, which requires a Conditional Use Permit. In most cases a business on the scale that the applicant has described would be a Home Occupation. However, the zoning code states that any business which involves storing or selling any stock in trade unless it is made on the premises must be considered a Home Industry.
