APPLICATION FOR PERMISSION TO ENGAGE IN FUNDRAISING ACTIVITIES

All Umbrella Organizations must have an approved "Application for Permission to Engage in Fundraising" on file with the City's Charitable Contributions Committee.

Umbrella organizations shall submit applications to participate in the Annual Charity Drives on forms provided by the Committee, which shall be available at the Office of the Mayor or the Mayor's designee. Each application shall be filed with the Office of the Mayor or Mayor's designee prior to February 15 of each year in order for the applicant to be eligible to participate in the Annual Charity Drives.

If the umbrella organization has been deemed eligible for a five-year period, application need not be made for participating in the Annual Charity Drives for the second through fifth years of eligibility. Each umbrella organization shall, however, provide the Committee with a written notice of intent that it wishes to continue its participation in the Annual Charity Drive between January 1 and February 15 of each year. The notice of intent shall be accompanied by a statement that the questions and supporting documentation contained in the original application remain correct and accurate. Any changes from the original application should be detailed and supporting documentation provided.

The Committee reserves the right to request a new application be completed.
