On 9/9/2025 I was driving EAST on Mac Arthur Road to pick up my child from school at 3:20 p.m. There was a large pothole on the right side of the road, approximately around location S26W26910 Mac Arthur Road. My front passenger side tire hit the pothole and caused the tire to be completely damaged and resulted in a fully flat tire.

My vehicle had to be towed, and the tire had to be fully repaired. Elders Towing Company towed the vehicle to Discount Tires located in Waukesha on Sunset Dr. Discount Tires replaced and repaired the tire. The cost for this was \$345.08 (receipt attached)

I had reported the concern with the City of Waukesha using the online portal. They closed the report, indicating that the pothole has since been taken care of. I have also attached the email with this information. I did drive back to the scene of the incident on 9/12/2025 and did see the hole repaired with blacktop.

I am asking for reimbursement for this invoice attached from Discount Tire. It seems that the pothole had been causing enough issues with previous drivers/vehicles that the pothole was fixed only 3 days after my incident occurred.
