Issue Before the Council: In late 2024, the City entered a Contract with MSA Professional Services to provide private development review services on an hourly, as needed basis. MSA has provided this service for the Engineering Division through the entirety of 2025 and has yielded very positive results for private development projects. Contract Amendment #1 is attached and only adjusts the hourly rates to the 2026 staff rates provided by MSA. All other Contract items remain as-is.

Additional Details: With the filling of some vacancies within the Engineering Division, MSA's primary role within Private Development Review is to complete reviews of submitted projects which can be billed back to the development applicants. While there may be minor hourly expenses that cannot be billed back to the individual applicants, the goal is to have MSA's time 100% covered by private development applicants by the end of quarter 1 in 2026. A brief summary 2026 hourly fee schedule is shown below:


Financial Remarks:
