Agenda Item Title:

Review and possible action on the Architectural Design Services Consulting Contract for 2025 and 2026 Community Investment Program (CIP) projects on an as-needed basis.

Issue Before the Council:

The Department of Public Works solicited proposals from consultants for Architectural Design Services on an as-needed basis for all phases of design, from programming, through bidding and construction administration, including cost estimating.

Options & Alternatives:

Another one of the consultants could be chosen, but ISG Inc. is recommended due to obtaining the highest score based on the scoring criteria established in the City's Request For Proposals (RFP).

Additional Details:

The RFP was sent to six consultants resulting in five responses. The city's review committee evaluated the responses based on the credentials and experience of the project team and firm, references and prior projects, and the cost of services provided. Below are the rankings of the firms:
