PLEASE TAKE NOTICE, pursuant to §893.80(1), Wis. Stats., that on December 12, 2025, Mr. Coffey was a lawful passenger on a City of Waukesha Metro Transit bus, operated by driver, Samuel Robert Olson. The City of Waukesha Metro Transit bus was heading eastbound on Sunset Drive approaching Navajo Lane, signaling to make a left hand turn onto Navajo Lane and turned into the path of an oncoming vehicle driven by Skarleth Mercedez Medina Lara causing nearly a head-on collision between the two vehicles. Mr. Olson, the driver of the City of

Waukesha Metro Transit bus was cited for *Fail/Yield While Making Left Turn (Resulting Bodily Harm)*, a violation of Wis. Stat. §346.18(2).

Mr. Coffey sustained serious injuries to his neck, back, right shoulder, and right knee requiring emergent transport via City of Waukesha Fire Department to ProHealth Waukesha Memorial Hospital for further evaluation. Mr. Coffey will require extensive follow-up medical treatment for these injuries.

The City of Waukesha, County of Waukesha, City of Waukesha Metro Transit, and City of Waukesha Metro Transit Driver, Mr. Samuel Robert Olson are negligent for their failure to properly maintain a safe, injury-free environment, and to maintain and follow the proper rules of the road to ensure the safety of its passengers.

Liability for Mr. Coffey's injuries and damages are attributed to the City of Waukesha, County of Waukesha, City of Waukesha Metro Transit, and City of Waukesha Metro Transit Driver, Mr. Samuel Robert Olson.

Mr. Coffey suffered permanent physical injuries and suffered mental anguish as a result of their negligence. All medical documentation will be supported upon Mr. Coffey's completion of medical treatment.

Mr. Coffey is seeking damages in the amount of \$250,000.00.
