Agenda Item Title:

Review and possible action on the Contract for Snow and Ice Removal on select routes throughout the City of Waukesha for the 2025-2026 season.

Issue Before the Council:

The Department of Public Works solicited proposals from 9 snow removal service companies. Services in this request included snow and ice removal for parking lots, sidewalks, trails, and alleys throughout the City. Contracting services for the routes included in the RFP allow staff to be reallocated from these routes and added to plow routes on City streets.

Options & Alternatives:

- 1. Approve Lump Sum Cost for High Priority Routes.
- 2. Approve Lump Sum Cost for Low Priority Routes.
- 3. Approve Lump Sum Cost for Alleys.
- 4. Approve any combination of the 3 scopes above.
- 5. Reject all proposals and continue to utilize City Staff to remove the snow and ice.

Additional Details:

- High priority routes include lots and sidewalks at City Hall, PRF (Aviation Dr), Frame Park, Schuetze Recreation Center, Waukesha Public Library, and Grede Park as well as the sidewalks at E.B. Shurts and the Waukesha Police Department.
- Low propriety routes include all other parking lots, sidewalks and trails currently maintained by PRF.
- Alleys include all alleys within City Limits.

Two service companies submitted quotes in response to the RFP, and the season-long lump sum amounts provided in these responses can be found in the table below:

Service Route	Jake's Landscaping	Snow Patrol, Inc.
High Priority Routes	\$44,890.00	\$238,000.00
Low Priority Routes	\$98,950.00	\$247,000.00
Alleys	\$72,678.00	\$153,000.00

In addition to the lump sum proposal, Jake's Landscaping has provided the following hourly pricing for additional services to be provided on an as needed basis:

ATV – 5' plow	\$100.00
Laborer- Snowblower/shovel/spreader	\$ 90.00

Quad axel dump truck	\$150.00
