### **Agenda Item Title:**

#### **Issue Before the Council:**

Parks, Recreation & Forestry is planning the Independence Day Fireworks display at Lowell Park. For enhancement of the event, staff is requesting approval of the contract to allow Hudsonite Productions representing 5 Card Studs to perform at the event.

#### **Options & Alternatives:**

Alternatives include not hosting entertainment during the event, which could adversely affect attendance and the success of the event.

#### **Additional Details:**

The Independence Day celebration spans two days to include the Neighborhood Beer Garden at Lowell Park in conjunction with a fireworks display on July 3<sup>rd</sup>. This event typically includes music and food trucks for the public to enjoy ahead of the display. The Independence Day Parade is on July 4<sup>th</sup>.
