


#### 2025 Ridership Summary


#### Fixed Route Ridership

1. Fixed Route Ridership has decreased 2% from 2024, however there was a 15% reduction in service hours in June when the route consolidation occurred.
2. Passengers per Revenue Hour has increased to 8.6 from 7.9 in 2024 which is a 9% increase. Passengers per hour from June – December 2025, after the route consolidation, is at 9.0. Passengers per Revenue Hour has increase 37% since 2021.

#### Metrolift Ridership

3. Metrolift ridership increased 25% from 2024.
4. Metrolift ridership has increased 61% since 2022 and projected to continue to rise.
5. Ridership is the highest for Metrolift since 2012.


**Annual Metrolift Ridership**
