Agenda Item Title: Review and possible action on the Conditional Use Permit for 830 W St. Paul Avenue	

#### Issue Before the Council:

Review and act on the Conditional Use Permit for 830 W St. Paul Avenue- A request to place a decoratively painted storage container behind the building at 830 W St. Paul Avenue in the B-3, General Business District for the storage of green coffee beans.

#### **Options & Alternatives:**

The Plan Commission could approve the application with or without conditions or deny it. If the application is denied the proposal will not be able to go forward

### **Additional Details:**

The applicant is looking to obtain a Conditional Use Permit to allow for a storage container behind the coffee shop at 830 W St. Paul Avenue. The property is zoned B-3, General Business District. The storage container will need a Conditional Use Permit under uses similar to and reasonably related to the permitted principal uses.

The purpose of the container is to store green coffee beans, which Café De Arts Roastery is growing. The applicant indicated that they needed more space for storage and the shipping container was selected because green coffee beans need to be in sealed storage. The shipping container is approximately 20' long, by 8' wide, by 8'6" tall. It will be placed along the back side of the building on the blacktop to obscure it from public view. The shipping container will be artistically painted to match the current art on the building. It will take up approximately two parking spaces in the rear. There will still be 15 parking spaces on site, with one being ADA and two being for compact vehicles next to the storage container. There is also adequate street parking.
