Issue Before the Council: Review and act on an rezoning request for 1300 and 1240 S Grand Ave from B-4 Office and Professional District to I-1 Institutional District.
Options & Alternatives: <ul style="list-style-type: none"> • Approve the rezoning request. • Deny the request and the parcel will remain zoned B-4 Office and Professional District.
Additional Details: Bridge Church has acquired the two properties to the north along Grand Ave and in anticipation of a future expansion project, is requesting the rezoning of 1300 and 1240 S Grand Ave from B-4 Office and Professional District to I-1 Institutional District. This is associated with the Land Use Plan Amendment request from Commercial (C) land use to Civic and Institutional (CIV) land use category, also on the July 23, 2025 Plan Commisison agenda. The majority of the church owned property is currently under the I-1 Institutional District, and these two parcels being rezoned will make the lands owned by the church consistent in their zoning designation. There will also need to be a public hearing on the Land Use Amendment and the Rezoning prior to Common Council action on these items.
